Two art works per entry. Size limits of actual work: 2 -D work maximum 12 sq. ft. (i.e. 3' x 4') 3-D work maximum 36" ht. x 24" wd. Works for sale must be priced to include commission (see below). All works must be delivered suitable for installation. NHArts reserves the right to refuse works that are different from images submitted.

This is a juried exhibition. Selected works for exhibition are curated by an independent juror.

Accepted artists will be informed of delivery and pick up dates via email.
